Regular meeting called to order by Commissioner Kennedy at 6:00pm, followed by the flag salute.

Commissioner Kennedy motioned to accounts payable in the amount of \$21,515.82, monthly payroll/payroll costs in the amount of \$19,347.70; seconded by Commissioner LaCount, motion carried.

OLD BUSINESS

Sedro-Woolley Agreement- Continued discussion regarding the agreement with the City of Sedro-Woolley. The Chief and Commissioners have come with some points of discussion for negotiation and commissioner Kennedy will reach out to the City to schedule a meeting in the near future.

Personnel- Chief Carpenter reported that applicant Chris Chapman meets all the district requirements and will be a perfect fit for the district, he plans on offering Chris the full-time firefighter position.

Apparatus- Chief Carpenter reported that the new battalion rig is going in for decals and radio installation soon. Chief Carpenter stated that another fire District may be interested in the Ford F-250 Pick-up that the district is going to surplus. Chief presented some information for pricing from like models/years/mileage ect.... Commissioner LaCount motioned to set the value of the pick-up at \$28,000, Seconded by Commissioner Kennedy; motion carried. Some discussion regarding future apparatus needs of the district and refurbishing trucks verse purchase. This discussion will continue in long range planning for the district.

NEW BUSINESS-

Minkler Rd BESS- There is proposed Battery Energy Farm to be built on Minkler Rd in the District. The community strongly opposed this facility. The Skagit County Commissioners have gone on record that they are opposed to this facility bet because this is considered green energy it gets approved at the State level rather than County level. Skagit Fire District 8 commissioners are aware of the proposed facility.
